A Piece of Legal Humour

Legal Opinion

Years ago I wrote a paper about the right to fish, ie rights and obligations as between fisher and land owners and the Crown. It occurred to me there was an omission concerning the right to fish on the domestic front, ie rights and obligations as between fisher and spouse.

In an illuminating US decision (Moore v Moore), the court considered a husband's application for divorce on the grounds of the infliction of indignities. It was held such conduct had to manifest cruelty or injury accompanied with insult or hatred. The evidential basis was wide ranging including her "harping" criticism of his trade activities, interference with his fishing, and the use of the appellation "hillbilly" to describe Lowell Moore's family. As to the last, the implication was that the description of a family from southern Missouri as hillbillies was probably not that wide of the mark and it was held, in any event and a little oddly, to be an expression of envy rather than hate.

More germane to our topic, the Court held in respect of the interference with the husbands fishing activities:

"... a husband has a right to go fishing. And we will go further and say that this right extends to fishing without the constant and ever present impediment of female presence and participation, if such be against the will of the husband. It is a wise wife who accords her husband that freedom – in moderation – and a foolish wife who interferes. The studied, constant, and repeated interference with that right over a long period of time could be, under certain conditions, an indignity ..."

While one deduces from the repeated use of the word right in italics that the Court's sentiments were heartfelt, Lowell Moore failed on the facts. His wife's interference with his right to fish – or right to fish – did not amount to a constant and studied course of conduct amounting to indignities that rendered life intolerable. The precedent value

of the decision is limited, in part due to the outmoded sexist language, however, one imagines the principle could be enshrined in gender neutral language. Moreover, in enlightened Australia we enjoy no fault divorce so that an interference with fishing activities can be actioned with divorce proceedings as of right, without discharging a legal burden of establishing the impugned conduct amounts to an indignity. Not that it is suggested that divorce is a rational response to interference with the right to fish (it might be). Indeed prudence dictates that neither the decision not this advice be disclosed to your spouse, or there will be trouble. Believe me, I know.

Quick trip report if someone was interested....

Lake Eucumbene 6-7 April

Arrived Anglers Reach boat ramp sunrise (0720) launched boat and headed straight for the Narrows and trolled Cowbells with worms and Ford Fenders with Rapala/Crickhopper combinations to the Portal. Fenders with worms managed 4 fish biggest 30cm smallest 22cm. Cowbells and a lure of some sort had no hits, swapped to lead line... No luck either.

In effort to find schools of fish to revert back to the fly, I motored back to the main hub of rises were. Loche fished a team of 2 flies; Hammils Killer and a polish woven spider on top, intermediate line with 16ft leader. I did think about running 3 flies, but I was not in a mood to make the setup on my existing leaders!

Reeled in 1x Brown @ 30cm and 1x Rainbow at 42cm both fish taking the top fly.... Nothing else until sunset.

Unpacking the swag, risers were everywhere, only little sprats... Swapped fly rods and tied on a Greenwell's Wet size 16. Landed a groovy little brown, an up and coming trophy!

Camp set up and loaded another fly rod up with a olive matuka and a small mudeye. 6 more Browns followed all 30-35cm with 3 bust offs.... Stopped fishing at 2230 as it was getting too cold and dark to cast with no moon.

Rose at 0730 headed half way up the portal and loche fished the bank and landed another Brown at 30cm. Nothing else for the day....

Providence flats is where all the boats are headed with over 10 counted Saturday and Sunday, but no reports as yet. I am of the opinion the fish are still feeding heavily in the Anglers Arm waiting for the cold and a good rain before they head into the rivers.

Kept 2 fish for the smoker...

Great weekend with small reports chatted about at the boat ramp of fish being caught of one or two.
