# June Chill - Eucumbene Outing Report

Having recently returned from a number of years in Singapore, Lyall has to be admired for his determination to get out fishing – regardless of weather. He's provided this excellent report of what turned out to be a reasonably successful trip.

# Rainbows at Anglers Reach June Chill CAA Outing



As forecast, the weekend of 28 and 29

June was a tad cold at Lake Eucumbene. With the weather so poor Allan and Lyall decided that it was more important than ever to hook up a fish to make the weekend worthwhile. In fact we made it a long weekend, driving down on Friday morning.

After stopping at the car park at Providence Portal to check out how far the walk was to the lake we checked in at Anglers Reach Caravan Park, ensuring that there was a heater in the cabin assigned to us. It turned out there was also a clothes drying cupboard which was to be used extensively after the frequent squalls to dry jackets and gloves before the next foray.

The fishing at Anglers Reach was a matter of trying every method in the book then sticking with what worked. Flies, bait (natural and artificial) and spinners were all experimented with.



A small green celta took a legal sized rainbow not far from Anglers Reach Caravan Park in Long Plain Inlet and then a bardi grub and worm landed another in the same inlet. At one point a nice sized rainbow was hooked up and jumping but spat the hook. In less time than it takes to say oncorhynchus mykiss, the bait on the dropper had been taken and there was a tug on the line. Unfortunately there was no hook up but at least the fish were clearly there.

Having checked in with Bryan Pratt before the trip, we were armed with Lime Twist Power Bait ('sounds like a good name for a cocktail') and Chunky Cheese flavoured Gulp (who makes up these names?). As fishermen do, we tried to analyse the difference between the Power Bait and Gulp, apart from the flavours of course, as both are Berkley brand, both are manufactured by Pure Fishing inc. 1900 18<sup>th</sup> Street, Spirit Lake, Indiana. It was one of those deeply philosophical discussions which went on for hours ...





having fun, we returned to our warm cabin and the drying cupboard, looking out at the sleet.

The afternoon saw us back at the boat ramp, with Allan landing more rainbows and chief photographer Lyall snapping the evidence. We fished into the night again until the sleet and wind made a tactical reverse advance necessary. The horizontal sleet reflected in the headlamps which made direction finding back to the cabin a challenge. I joked that we would be telemark skiing down to the boat ramp the next morning —

As it turned out Chunky Cheese worked wonders. Allan fished the inlet up to the Anglers Reach boat ramp and at around 4.00 pm started landing fish after fish into the darkness on Chunky Cheese with the fly rod getting a work out but not yielding any joy. It was enough to have us both fishing into the night then back there before dawn. As a particularly bad storm rolled down the opposite bank of the lake and approached us, we stuck it out until all we could do was turn our backs on the lake and on-coming storm and hold the fishing rods backwards hoping for a bite. At the point we decided we were no longer





bad move – I should have kept my mouth shut.

Sunday morning we awoke to a white carpet of snow, children sliding down the hill on sleds and doubt in my mind whether the Ford Falcon would be able to make it up the hill and back to Canberra in the snow. By checkout time, enough four wheel drives had driven the road to leave two wheel tracks to follow even though it was still snowing.



The best fish of the weekend was Allan's

48 cm rainbow and curiously, all fish landed over the weekend were rainbows which was not consistent with all the recent fishing reports. We concluded that all the brown trout must have already begun their journey up the rivers and creeks to spawn, leaving only rainbows for the few winter fishermen silly enough to brave the weather.



# Fisher's Watch

Member's may have wondered what the "Fisherman's Watch" with its 1 800 phone number on the back of our membership card was all about. The latest newsletter from Recreational Fishing Alliance of NSW has an item all about this service – including its name change. This is the service we should be using if we spot some illegal fishing activity – am aware that Jason Q had some experience of this during the river closing period.

# Interactive voice response system boosts Fishers Watch

In June 2012 NSW DPI implemented a new interactive voice response (IVR) system to the Fishers Watch 1800 number (1800 043 536). This system operates outside all business hours and two days a week during business hours. Previously when calls were made to the Fishers Watch service outside business hours the caller could only leave a message which would not be picked up until the next business day.



NSW DPI built the IVR system in house and were able to integrate it into the main compliance business information system called 'Nautilus'. The IVR system operates by requesting the caller to leave a message about the activity and stay on the line to use a menu to identify whereabouts the activity is taking place. The system then constructs SMS/Email notifications and sends them direct to the officers based in the area. There are some other features built in to also let the caller identify those calls relating to fish kills and abalone/rock lobster theft so that other specialist fisheries staff are also notified.

If the officer has been issued a smart phone/tablet (many now have been) they can listen to the message direct which is attached to the email as a recorded file, or if they have a non-smart phone they can log in to the IVR direct via a phone call and listen to the message that way. They can then initiate a response which could

include calling the informant back and/or attending the scene immediately. Afterwards they can then use the internal 'Nautilus' system to value add to the record which may include making file notes, attaching files or sending notifications to other officers with an interest in the report. The information then performs an important intelligence role when reviewing compliance problems around the state requiring attention.

Since its inception, the system has led to a many very good outcomes which have involved people reporting illegal activity and fisheries officers being able to respond very quickly because they happened to be located in the area. At times this has been in full view of the caller.

Fisheries Officers obviously don't work 24 hours a day/365 days a year so they can't guarantee that the message will be immediately received. Also some callers leave the message but don't stay on the line to record the location so it may not be forwarded to the affected officers until the next business day. However fisheries officers will return the call when possible if appropriate: the system allows the caller to confirm if they would like to be contacted and if so identify the correct number.

There is also an on-line report form.

Fisheries ask that you record the following information before reporting:

- Type of activity
- Time, date and location of activity
- Number of people and any descriptions
- Registration numbers of cars and boats.

# The Things You Hear About When Travelling

I was wandering around Eumundi markets during my recent travels when I spotted one gent wearing a polarfleece with a fish badge – looking more closely I saw it related to a past fishing competition in New Zealand. I fell into conversation by mentioning that our good friend, ex-President and generous sponsor Dr Bryan Pratt was in New Zealand at that very moment engaging the 'traditional opponent' in a fishing competition. The gent identified himself as Graeme Baylis and related a tale about Bryan running into trouble with the quarantine officials during the trip they shared. Seems Bryan was keen to show the kiwis how to catch snapper on soft plastics and he had brought some in his luggage. There was some concern as to whether



his soft plastics were to be declared as food – "only for a fish" was Bryan's response, however the New Zealand position on nuclear powered craft entering New Zealand was almost enacted when Bryan described the soft plastics as "Nuclear Chicken". Graeme did say they eventually got through the gate, but it was a close run thing.

# **Upper Murrumbidgee Demonstration Reach**

At our June meeting, Shane Jasprizza (President of CRFA) spoke on CRFA (presentation is available <a href="https://exemptics.org/ncsentation">here</a>), but also invited Antia Brademann facilitator of the Upper Murrumbidgee Demonstration Reach, along with Peter Saunders from Bush Heritage Australia's site at Scottsdale on the Murrumbidgee. Antia provided a very informative presentation but also invited us to assist the aims of the two organisations (ie to help restore the health of the upper Bidgee). The UMDR are undertaking substantial effort to understand the habits of the carp in this region in order to identify ways we can reduce their impact and assist the restoration of natives such as the Macquarie Perch. Note that much of the research and knowledge on European Carp comes from the low areas around the Lachlan and below – very different to our environment.

There are a number of initiatives that CAA are hoping to assist with:

 Angler's Diaries – a number of avid anglers have been identified to participate in the Angler's Diary program. Antia has indicated that records from trout anglers in the upper Murrumbidgee would still be welcome as there has been suggestions that some carp have been caught up as high as Adaminaby. Jason Q has volunteered to be one of the anglers, but also to collate any

• On-line reporting, in due course there will be an on-line web portal to report feral fish — will keep folk apprised as information comes to hand. CAA may be invited to be part of the testing of the website.



- Tagged carp photos are in the presentation of what they might look like, but if by chance you do catch one of the 30 tagged carp, please take some notes and return the fish unharmed. They are only few in number and are carrying an expensive audio beacon that will be used to track where the fish are travelling.
- Regional carp-out at this time the Australia Day event in Southern ACT is not a formal CAA outing, but our engagement is sought. More information closer to the date. Support from anglers in our club is sought by identifying suitable locations for the Carp Out – this is being run by Southern ACT Catchment Group. Perhaps Charlie's carp interest group might like to do some explorations away from their current favoured spots.










She has books too, but these have not been costed – please offer a fair price.

#### **Matters Arising**


